

**BYLAW TO DESIGNATE MUNICIPAL HERITAGE PROPERTY**

Section 12, *The Heritage Property Act*, R.S.S. 1978m c.H-2.2, as amended

**BYLAW NO. 02/2000**

A bylaw of the

**RURAL MUNICIPALITY OF LOREBURN NO. 254**

to designate a site as Municipal Heritage Property.

**WHEREAS** Sections 11 and 12 of *The Heritage Property Act* authorize the Council of a Municipality to enact bylaws to designate real property, including all buildings, features and structures thereon, to be of heritage value; and

**WHEREAS** the Council of the Municipality has determined that the lands and premises known as:

**The Bonnie View Church**

and located at:

1 1/2 miles South and 7 miles West of the Village of Loreburn, Saskatchewan

is a site of architectural, historical, cultural, environmental, archaeological palaeontological, aesthetic and/or scientific value; and,

**WHEREAS** the Council of the Municipality has caused, not less than thirty (30) days prior to consideration of this bylaw, a Notice of Intention to Designate to be:

- a. served on the owners of said property;
- b. served on the Registrar of Heritage Property
- c. registered on the Certificate of Title for said property in the appropriate Land Titles Office; and,
- d. published in at least one issue of a newspaper in general circulation in the municipality; and.

**WHEREAS** no Notice of Objection to the proposed designation has been served on the Council of the Municipality;

**THEREFORE**, the Council of the Municipality enacts as follows:

1. There is designated as Municipal Heritage Property the real property legally described as:

All that portion of the South East Quarter of Section 15, Township 26, Range 6, West of the Third Meridian, Saskatchewan Described as follows:  
Commencing at a point on the Eastern boundary 563.40 feet Northerly from the South East corner thence Northerly along the Eastern boundary 137.30 feet, thence Westerly and parallel with the Southern boundary 238 feet, thence Southerly and parallel with the Eastern boundary 137.30 feet, thence Easterly and parallel with the Southern boundary to the point of commencement. **THE BONNIE VIEW CHURCH**

**BYLAW NO. 02/2000**

The reasons for the designation are as follows:

The reasons for the proposed designation are as follows:

- a. Bonnie View Union church congregation was formed in 1905 for members of several denominations. It was therefore called 'Union Church', although under the auspices of the Presbyterian Mission. In the mid-twenties it was decided that a church be built. The brick building was built by the congregation and was dedicated in 1928, free of debt. The Bonnie View Church was officially closed in 1958. The Bonnie View Church was a place of unions, worship, and gatherings for the area for over 30 years.
- b. Built by the members of the congregation, both with their labor and funding. No money was used from the Church's coffers. The congregation found pride in their resourcefulness but also in the workmanship of the building. It remains a local landmark, both historically and architecturally.
- c. Many of the members of the community still have strong ties to the Bonnie View Church, and wish to see it standing for years to come.
- d. A local foundation has been formed called "The Friends of the Bonnie View Church" of which the landowner is a part of, who wishes to preserve the structure.

2. The Municipal Administrator is hereby authorized to cause a Notice of the Designation to be:

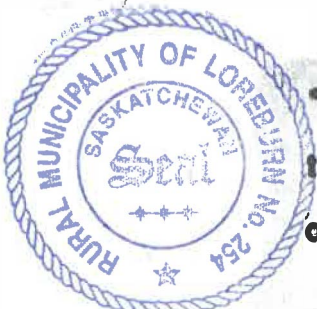
- a. Registered on the Certificate of Title for said property at the appropriate Land Titles Office; and,
- b. served on the owners of said property.

3. The Municipal Administrator is hereby authorized to cause a certified copy of this bylaw to be served on the Registrar of Heritage Property.
