
## A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT BETWEEN THE RURAL MUNICIPALITY OF LOREBURN NO. 254 AND THE VILLAGE OF LOREBURN FOR THE PURPOSE OF ROAD CONSTUCTION OF THE ACCESS TO THE LOREBURN LAGOON

The Council of the Rural Municipality of Loreburn No. 254 in the Province of Saskatchewan enacts as follows:

- 1. That the Rural Municipality of Loreburn No. 254 enter into an agreement with the Village of Loreburn which will allow the rights and responsibilities along with payment plan to be itemized in Schedule "1" that is attached, for the access road to the Village of Loreburn lagoon in Schedule "A".
- The Reeve and Administrator of the Rural Municipality of Loreburn No. 254 are 2. hereby authorized to sign and execute the attached agreement identified as Schedule 1.
- 3. Accounts shall be paid within in accordance with Schedule "1" agreement.

The agreement shall come into force and take effect on the day of passing and shall be in effect until 2025 or until the amount stated in 1.4 of Schedule "1" is paid in full.

### ROAD CONSTRUCTION AGREEMENT

### between

### THE VILLAGE OF LOREBURN (Village)

### AND

# THE RURAL MUNICIPALITY OF LOREBURN NO.254 (R.M.)

WHEREAS the parties wish to enter into an Agreement for the purpose of constructing a road to access the Village lagoon upon land described in Schedule "A";

AND WHEREAS the parties wish to set out their respective rights and responsibilities in this Agreement;

IN CONSIDERATION of the mutual promises contained in this Agreement, the parties agree with each other as follows:

#### Part 1: Acquisition, Construction & Costs

- 1.1 That the Village purchase the land required as noted in Schedule "A" on the map.
  - 1.1.1 The R.M. acknowledges that the Village is the registered owner of the land in Schedule "A".
- 1.2 That the R.M. will tender the road construction, choose the tender and oversee the road construction.
- 1.3 The parties agree that the associated construction costs will be split as follows:
  - 1.3.1 Village pays for:
    - 1.3.1.1 Land acquisition
    - 1.3.1.2 Community Planning Fees
    - 1.3.1.3 Title Transfer Fees
    - 1.3.1.4 Signage
  - 1.3.2 R.M. pays for:
    - 1.3.2.1 Surveying
    - 1.3.2.2 Removal of existing fence
    - 1.3.2.3 Cost to construct lagoon access road
    - 1.3.2.4 Materials and installation of new fence & gate
- 1.4 It is agreed that the costs that will be paid for by the R.M. is the total of items listed in 1.3.2.
- 1.5 It is agreed that the Village will pay the R.M. back for the amount in 1.4 as follows:
  - 1.5.1 That \$100 per site per year (as per Bylaw #6 Schedule 1) will be paid to the R.M. starting July 1, 2021 for a period of 5 (five) years or until the amount as stated in 1.4 is paid in full (see Schedule "B").

## **Part 2: Arbitration**

2.1 Any dispute or disagreement arising from the parties' inability to come to a joint decision in relation to this Agreement that is not settled by mutual negotiation can be referred by either party to a single arbitrator for binding arbitration. The decision of the arbitration shall not be subject to review by a court of competent jurisdiction, excepting the arbitrator's jurisdiction to make such a decision.

## Part 3: Miscellaneous

- 3.1 That this Agreement shall not be assigned without the written consent of both parties.
- 3.2 That in the event of amalgamation or the formation of a Municipal District, this Agreement shall be binding upon the amalgamated municipalities/municipal district.
- 3.3 Each provision of this Agreement is intended to be severable. If any provision is illegal or void, such illegality or invalidity shall not affect the validity of the remainder of the Agreement.


