BYLAW NO. 02-2023

RURAL MUNICIPALITY OF LOREBURN NO. 254

A BYLAW TO SET POLICIES AND PROCEDURES FOR A WASTE DISPOSAL GROUNDS

e Council of the R.M. of Loreburn No. 254 enacts as follows:

- 1. In this Bylaw the following definitions shall apply:
 - a) "Administrator" means the administrator of the municipality;
 - b) "Bulk Refuse" means wood, trees, shrubs, stumps, branches;
 - c) "Council" means the council of the Rural Municipality of Loreburn No. 254;
 - d) "Designated Areas" means separate sites within the waste disposal site, set aside for the disposal of particular wastes ie: domestic wastes and rubbish, wood, and metal;
 - e) "Municipality" means the R.M. of Loreburn;
 - f) "Owner" means the R.M. of Loreburn
 - g) "Public highway" means a road allowance or a road, street, or lane, vested in Her majesty or set aside for such purpose and includes the entry road to the waste disposal grounds, culvert, drain or other public improvement erected upon or in the connection with such public highway;
 - h) "Ratepayer" means the registered owner of real property as shown on the Municipality's tax roll or resides in the Municipality;
 - i) "Refuse" means all waste including domestic waste rubbish, street cleanings and yard clippings but does not include liquid domestic waste;
 - i) "Resident" means residents of the R.M. of Loreburn No. 254;
 - k) "Scavenger" are persons authorized by council to collect domestic waste for removal to the transfer station;
 - 1) "Waste Disposal Grounds" means the municipal waste disposal grounds located on the North West Quarter of Section 1 in Township 27 in Range 06 West of the Third Meridian;
 - m) "Whites" means large metallic objects such as major appliances, water heaters, stoves, furnaces, washers, dryers, refrigerators, deep freezes, dishwashers, gates, etc.;
- 2. Ratepayers, except commercial businesses, of the municipality shall have access to the waste disposal grounds to dispose of their garbage created from their rural property on the regular days and hours of operation as set by council.
- 3. It will be recommended that if ratepayers have a bigger project that they must rent their own bin. Some examples of projects would include, cleaning out a house, bigger renovation projects, cleaning up a farm yard, etc.
- 4. The On-site **Blue Recycling Container** will accept Containers (rinsed and all caps and lids removed) includes water bottles, soft drink cans and bottles, beer cans, milk jugs and cartons, detergent bottles, windshield washer fluid bottles, tetra-pak boxes, tin cans, juice containers, yogurt and margarine containers. Plastic containers must have the recycling arrows and a number inside, Paper and Cardboard includes newspapers, magazines, catalogues, office paper, envelopes, junk mail, cardboard, cereal boxes, tissue boxes, paper towel cores, bathroom tissue cores, paper bags, gift wrap, telephone books, hardcover books with covers and spin removed.

Items NOT allowed: motor oil jugs, plastic toys, outdoor lawn furniture, plastic bags and food wrap, plastic or wire clothes hangers, hazardous chemicals, glass cups or dishes, ashtrays, window glass, auto parts and scrap metals, styrofoam, plastic pipe, light bulbs, batteries, plastic containers without the recycling arrow and number inside, soiled tissues, napkins or paper towels, waxed paper, food contaminated paper or cardboard, garbage, organics, confetti paper, black plastics.

Items for the blue recycling container may be changed at the discretion of the service provider.

5. The Red Loraas Container will take all refuse with the exception of: compost, organics, hazardous waste including paint, solvents, chemicals, etc., sod, dirt or concrete, ashes of any description, construction or demolition materials including boards, roofing materials, carpet, etc., automotive parts, oil filters, oil, batteries, tires, etc., tree clippings over 2' in length, liquids of any kind, animals or animal parts.

Items for the Red Loraas container may be changed at the discretion of the service provider.

- 6. All refuse, bulk refuse and whites shall be deposited in the designated areas of the waste disposal grounds; only unpainted, untreated raw lumbers shall be deposited in the wood pile.
- 7. Hazardous wastes of any kind: pesticides and other hazardous wastes, or any materials treated with any of those substances, including the receptacles containing them; chemicals which are radioactive, reactive, toxic ignitable, corrosive, pathological, acidic, etc, or any waste which is otherwise listed as a hazardous or toxic substance; petroleum contaminated soils; any liquid paint and solvents; oil or used oil and their containers, liquid wastes and sludges generally; acid-filled automotive batteries; rechargeable batteries; propane tanks; cellular phones, laptop computers, camcorders, digital cameras and remote control toys, televisions and power tools; refrigeration and air-conditioning equipment; rubber tires; and any wood products treated with creosote (telephone poles, wooden pilings, railroad ties, etc) shall not be accepted at the waste disposal grounds.
- 8. Construction rubble of any kind shall not be accepted at the waste disposal grounds.
- 9. Refuse that is the remains or by-product of slaughter house operations; and liquid domestic sewage shall not be accepted at the waste disposal grounds.
- 10. Automobiles or other large metal objects shall not be accepted at the waste disposal grounds.
- 11. Tires shall not be accepted at the waste disposal grounds.
- 12. No burning barrels or ashes shall be accepted at the waste disposal grounds.
- 13. Absolutely NO burning is allowed at the waste disposal grounds unless authorized to do so by the R.M. of Loreburn or its representatives.
- 14. No person shall deface, destroy or alter any signs, gates or fencing at the waste disposal grounds.
- 15. The waste disposal grounds will be open only on specific days and times as set out in Appendix "A". Days and/or hours of operation may be changed by resolution of Council of the R.M. of Loreburn and attached to this bylaw.
- 16. The operator of the waste disposal grounds shall keep a daily register of all persons using the site.
- 17. All expenses shall be those of the Owner and will be off set by any revenue from scavenging and agreement fees.
- 18. Signs shall be erected stating the rules of the operation and to mark the designated areas.
- 19. A person who infringes any of the provisions of this bylaw or fails to comply therewith shall be liable to a summary conviction to a fine of not less than \$500.00 in addition to the R.M. of Loreburn's clean-up and legal costs.

20. Bylaw No. 09-2016 is hereby repealed.
